



**VOTING RESULTS OF THE EXTRAORDINARY GENERAL MEETING OF SHAREHOLDERS OF FCA N.V. HELD
ON FRIDAY SEPTEMBER 7, 2018**

As of August 10, 2018 – the record date for the EGM - the Company's outstanding share capital amounted to 1,550,617,563 common shares and 408,941,767 special voting shares, each share having a nominal value of one eurocent, including at that date 32,909,001 special voting shares held by the Company itself. Each share carries one vote. In total, 1,926,650,329 votes may be validly cast.

At the EGM 71.52% of all outstanding shares in the capital of the Company were present or represented at the meeting. The total number of voting rights at the meeting amounted to 1,377,880,313.

In accordance with Section 2:120 paragraph 5 of the Dutch Civil Code, the outcome of the votes on the proposal discussed at the meeting is as follows:
